DEED POLL

I know all men by these presents which are intended to be enrolled in the High Court in the Republic of Ireland that I the undersigned Mary Helebert of William Street West, Galway citizen of the Republic of Ireland aged eighteen years and upwards do hereby:

For and on behalf of myself, my future heirs and issue wholly renounce, relinquish and abandon the use of my former surname of Linnane and in place thereof do assume and adopt from the date hereof the surname of Helebert so that I my future heirs and issue may hereafter be called known and distinguished not by my former surname of Linnane but my assumed surname of Helebert.
