1. I, Michael Conneely, Architectural Technician of the above address, have been retained by Mary Helebert, 9 William St West, Galway and hereby certify as follows:-
2. I have been in independent private practice on my own account for upwards of ten years.
3. I am the consultant retained by Mary Helebert to prepare planning drawings and to make periodic inspections during course of construction of shop front and internal renovation works at 9, William St West, Galway viz. "The Old Forge" hereinafter referred to as "the relevant works".

1.. The timber work of the shop front (which shall be constructed precisely in accordance with the details shown) shall be painted with a coloured gloss paint. No signs other than those indicated on the submitted drawings shall be erected on the building.

REASON:

To ensure the building maintains an acceptable standard of appearance.

2.. The security shutters, if required, for the building shall be located behind the window area and shall be of the lattice see-through type and shall be coloured similar to the shop front.

REASON:

To provide that the building shall maintain a reasonable external appearance outside of the normal shopping hours in order to maintain a high standard of external appearance at all times.
