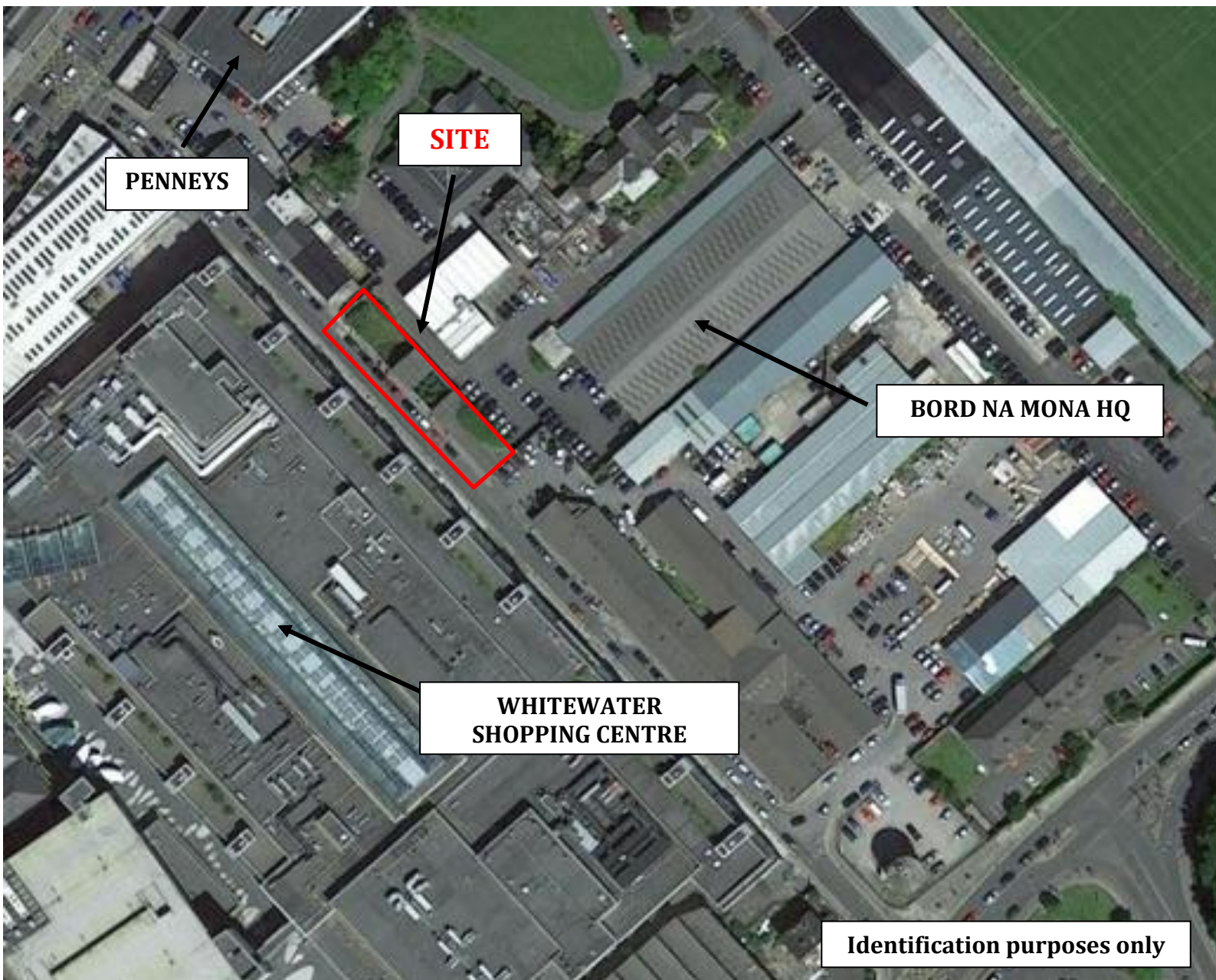

LOCATION:
