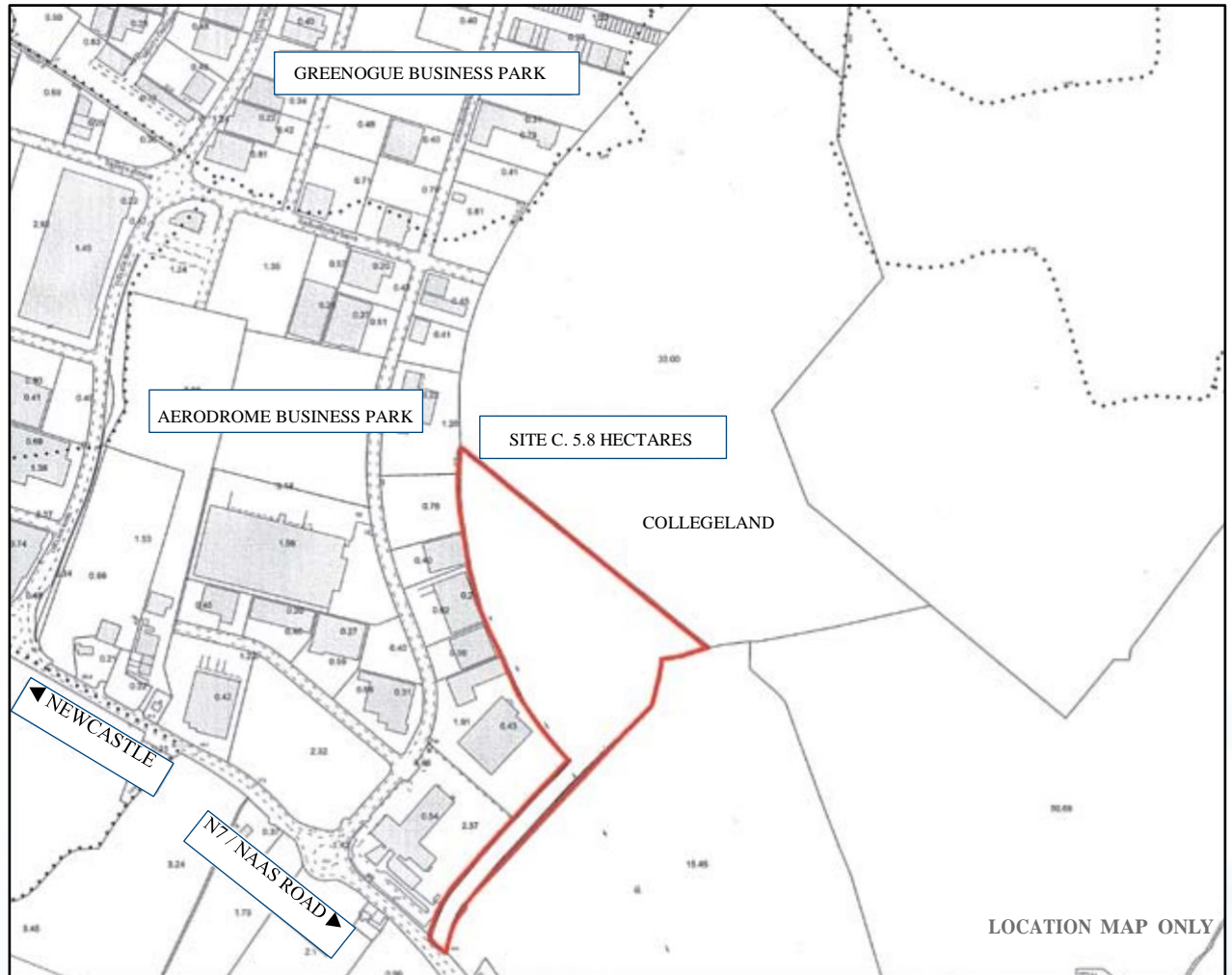

Situated just off the N7 Naas Road at the Rathcoole Interchange (Exit 4) in pivotal position beside the highly successful Aerodrome and Greenogue Business Parks. This location offers excellent access to the National Roads Network, Dublin's orbital Motorway M50 linking all sides of Dublin City is just 10 minutes drive time. The outer ring road is just three minutes drive which currently links the N7/ Naas Road, N4 Lucan By-Pass and the N81/ Tallaght By-Pass. Dublin Airport can be accessed in 20 minutes. Belfast, Galway and Rosslare Port are only 2 hours away while Cork can be reached in 2 ½ hours.
