LOCATION:

Situated in the sought after location with access directly from Daingean Road and also from the Grand Canal Court Residential development in Tullamore Town Centre. The property is located within easy walking distance of all amenities, shops, schools, church, pubs, restaurants, etc

Tullamore is part of the Midlands Gateway along with the nearby towns of Athlone and Mullingar. Tullamore lies on the N52 national secondary road & connects to Birr in the southwest and continues towards Mullingar which is located to the northeast. At Kilbeggan (c. 12km north of Tullamore) the N52 forms an interchange (Junction 5) with the M6 motorway which connects Dublin and Galway. Train service available to the City.

As the county town of Offaly many government services are located here such as the headquarters of Offaly County Council, the Midlands Regional Hospital and HSE services along with government departments such as the Department of Agriculture and Department of Education & Skills. It is also an important industrial, retail and services centre for the county.

Full planning permission was granted under ref. 17332 on 30th November 2018.
