#### **OVERVIEW**

Citywest is a fast growing suburb located South-West of Dublin. Although originally developed as a business campus, the area has an expanding residential element with over 8,000 residents.

Citywest Business Campus, which is situated just 1km from the development, is an award-winning business park and is home to over 200 companies.

Citywest Shopping Centre is located just 200m from the available units which generates a footfall of over 2.4 million people annually.

The total development will include c.750 residential units split between a previous phase of circa 350 units and the current phase of circa 400 units, including 4 commercial units split between retail & offices use.

The retail units will trade at ground floor level and will face on to Fortunestown Luas Stop.

The available units range in size from 176 sq.m. to 373 sq.m. and include a number of car park spaces.

### TRAVELLING TO CITYWEST

**BY CAR:** The M50, N7 and N82 provide a direct link from Dublin City Centre to Citywest taking around 40 minutes.

**BY LUAS:** Citywest is located just 50 metres from the Fortunestown Luas Station, providing direct connection links into Dublin City Centre and beyond.

**BY BUS:** Dublin Bus provides multiple services to and from Citywest. The main routes being 65, 65b, 69 and 77a. The Ard Mor Drive bus stop is located just 350m from the development.









Eastern Public Park View showing the linear park link.
