

This three-storey property is sympathetically renovated in recent years. The property offers excellent commercial potential or could also be readily adapted into a stylish private residence.

The ground floor comprises a welcoming reception hallway leading into an inviting restaurant area on either side, along with a fully equipped commercial kitchen, ancillary service areas, and guest toilet facilities. The upper floors offer five individually styled guest bedrooms, each with its own en-suite bathroom.

To the rear of the property is a generous yard with access from the side road. The yard could have potential for further development subject to a grant of planning permission. The property is connected to all town services and benefits from oil-fired central heating, a mix of hardwood and PVC double-glazed windows, and a modern infrastructure throughout.

Located on the renowned Wild Atlantic Way, Castletownbere is surrounded by the stunning scenery of the Beara Peninsula. The area is famed for its coastal walks, historical and archaeological sites, and is home to the internationally renowned Dzogchen Beara Retreat Centre. The bustling harbour and surrounding waters also make it a haven for sailing and fishing enthusiasts.

This is a rare opportunity to acquire a versatile and beautifully maintained property in the heart of one of West Cork's most popular and picturesque towns – whether for continued commercial use or as a distinctive private home.
