c.19 acres (c.7.69 ha) Blessington, Co. Wicklow

Part zoned development lands extending to c.19 acres with road frontage and superbly located on the edge of Blessington.

T he subject property comprises of c.19 acres (7.69 ha) of part zoned lands, in a mature setting with access onto the R410 Naas road on the outskirts of Blessington. The zonings include c.4.1 acres (c.1.65 ha) for new residential use, c.3.45 acres (c.1.4 ha) for educational use with the balance of just over c.11 acres zoned for agricultural use.

In addition, the lands will also be adjacent to the proposed new relief road upgrade which will improve local access to the N81 to Dublin and aims to facilitate future development along with improving public transport in the immediate vicinity.







Location

Blessington is a thriving commuter town located just off the N81 and approximately 29km south of Dublin city and one of the largest towns in West Wicklow. Situated beside the Blessington Lakes and the Wicklow mountains, providing excellent outdoor activities including water sports and hill walking. The town has grown to a population of over 6,000 and is extremely popular with commuters relocating to the area. Transport links are excellent and include the N81 and Dublin Bus commuter route which provide easy access to the M50, M7 and the Luas at Citywest. The town also offers an abundance of local amenities which includes, supermarkets, shops, pubs, restaurants and local schools, making it an attractive place within which to live.
