REA Grimes are delighted to bring 5 Netterville Terrace, Laytown to the market. This stunning Georgian Mid Terrace 3 bedroom home is situated on the beautiful coastline of Laytown and boasts uninterrupted views of the Irish sea.

This amazing house was built c.1760 and has been recently restored whilst keeping some of the original details intact. This beautiful house is part of a terrace of 11 houses - 5 Georgian c.1760 and 6 Victoria houses c. 1900. Netterville Sea Lodge was built as a single designed house in the vernacular of the late Georgian style. It is now divided into 5 stunning homes known as Netterville Terrace.

Laytown is a quaint coastal village in County Meath located approx. 30 minutes drive from Dublin Airport with a host of amenities close by including shops, schools, cafés, restaurants, bars and leisure facilities and clubs including golf, rugby, football, GAA, tennis, beaches and coastal walks. Laytown is served by Laytown Train Station and Matthews bus service, both of which are a few minutes walk from the property. Laytown is easily accessed by driving north on the M1 and taking exit 7 at Julianstown.
