Potential is the keyword here, with approx. 0.25 acres providing a potential development opportunity, subject to the necessary consent and planning permission, with an immediate interim rental income from the existing properties. Similarly, it may suit an astute investor seeking to add value through an upgrade or redeveloping of the existing properties and redivision of the rear gardens between the two houses. Alternatively, it will appeal to an owner occupier seeking to downsize to a quiet cul de sac off the mature and leafy neighbourhood of St. Kevin's Park, or, with some reconfiguring and restructuring (s.p.p.), to those looking for a detached home with large gardens in the heart of Dublin 6.

Nestled at the bottom of a quiet cul de sac, shared with only one other property, the location off St. Kevin's Gardens is hugely sought after, within walking distance of Rathgar, Ranelagh, and Rathmines. The location offers the best of both worlds, tucked away from the hustle and bustle while still enjoying every conceivable amenity within close proximity. The Luas stop at Milltown is a short walk including an array of eateries shops and boutiques. Some of Dublin's best schools and colleges are nearby including Sandford National, The High School, Muckross College, Alexandra College, Sandford Park, Gonzaga College, and Kildare Place. UCD and Trinity College are also within easy reach.

A host of recreational facilities and sports clubs are nearby including Palmerston Park, Dodder Linear Park, Milltown Golf Club, Brookfield Tennis Club, and Dartry Health Club. The area is also well serviced by public transport with several bus stops on within 300 meters on Dartry Road and a Luas stop at Milltown approx. 1km away.

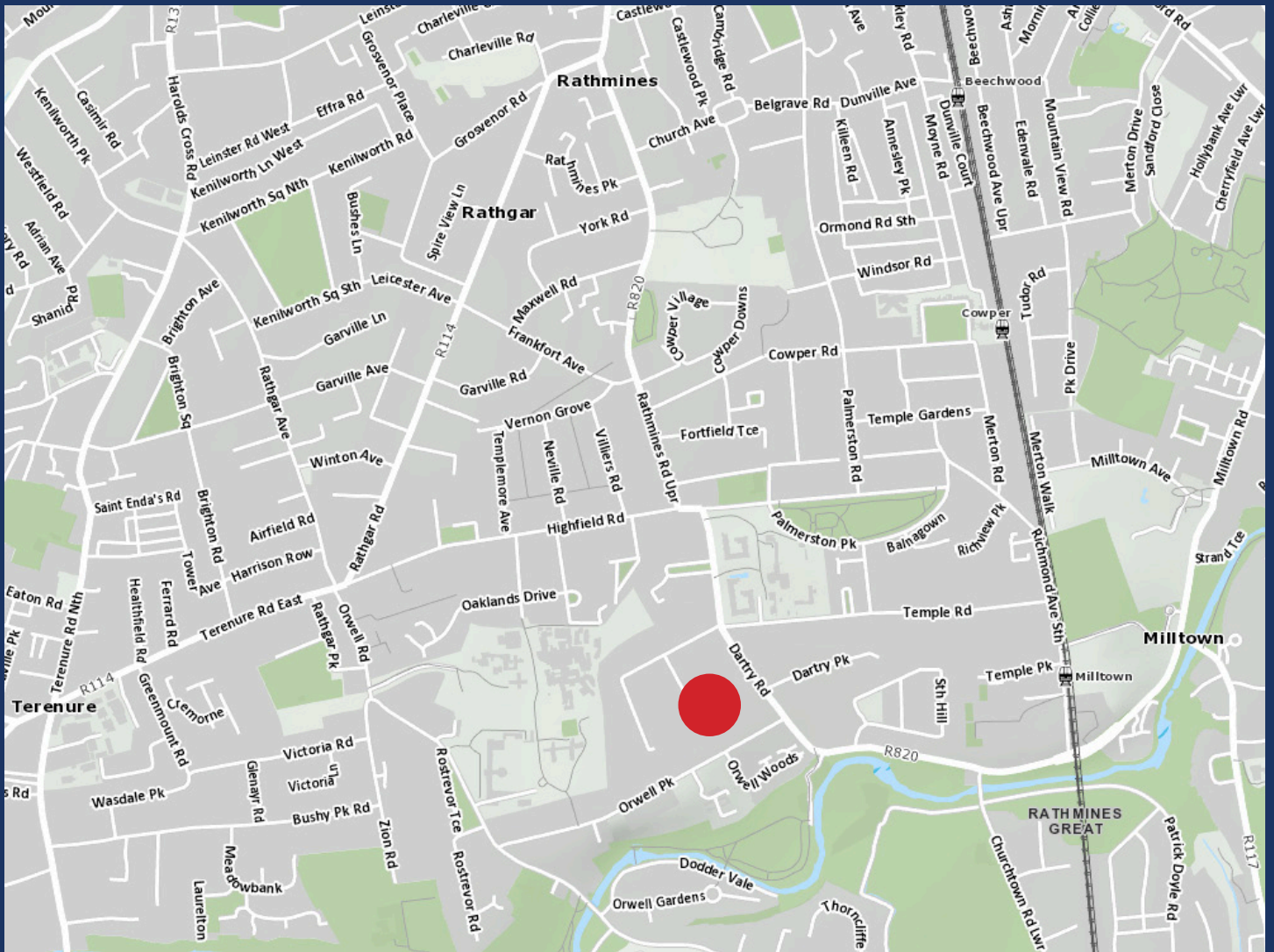
