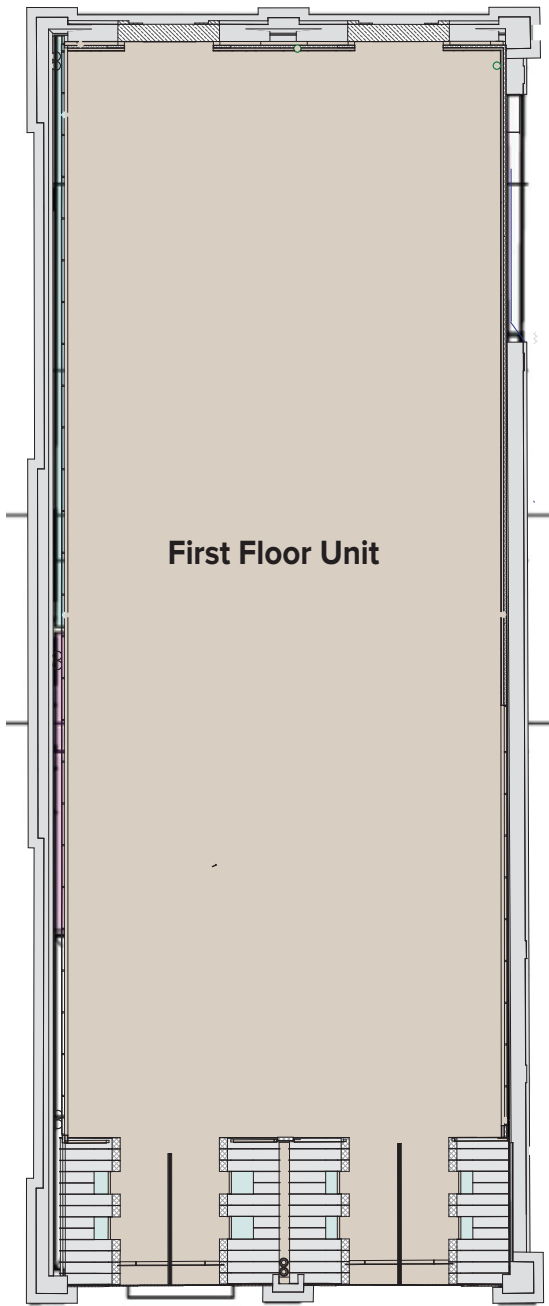

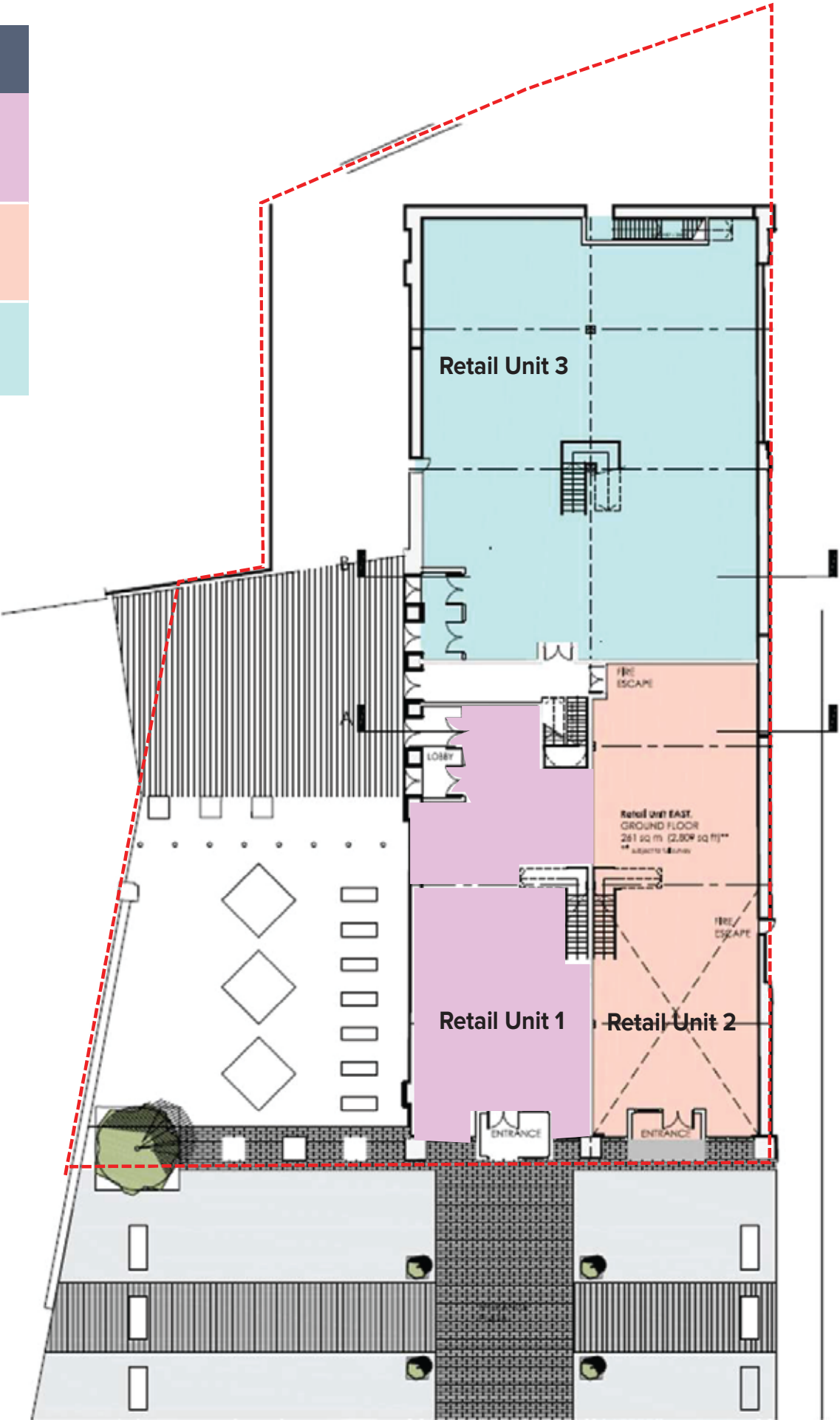

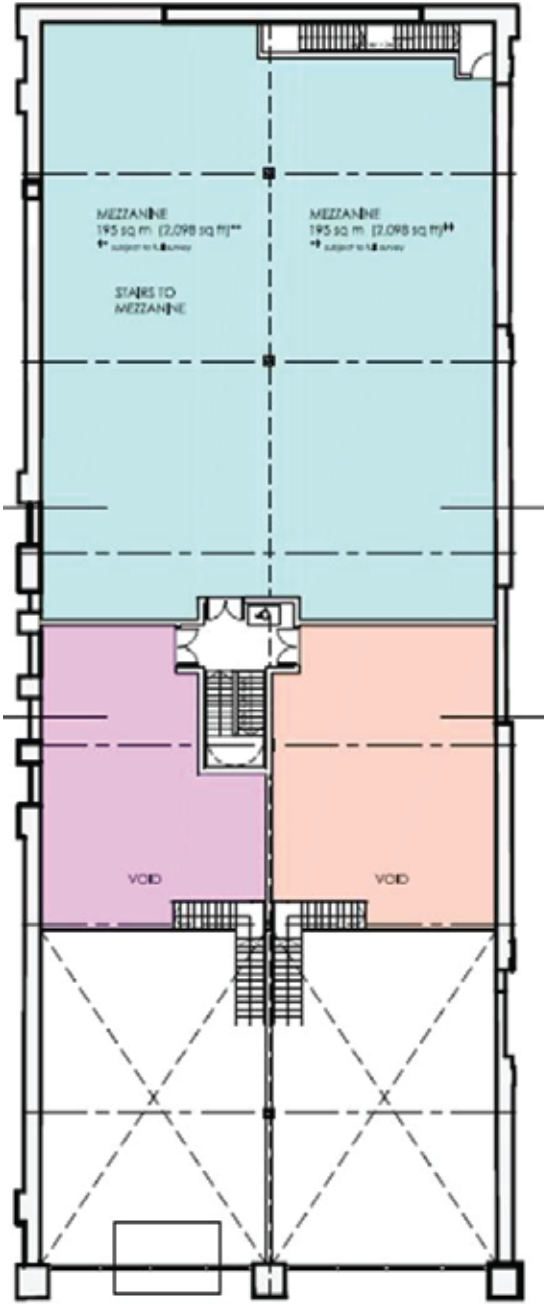

HQ CORK

Is one of Ireland's most significant and exciting urban redevelopments.

Spanning 6 acres along the River Lee, the construction has started on the office block which when completed will accommodate over 3,600 people. The planned construction of over 300 apartments will also commence later this year. The development of the adjoining site Penrose Dock will also see an influx of approx 2,400 people to the area.

The Horgan's Quay site's rich history dates back to the 1800s when the Great Southern & Western Railway Station first opened there.

PRIME LOCATION

Its prime location provides unrivaled access with vast appeal to residents, global firms and promising start-ups. HQ Cork is located less than 500 meters from the city's central bus terminus and directly served by local and mainline trains. The site lies just 15 minutes drive to Cork airport - the country's second largest airport with domestic and international connections daily.

THE CARRIAGE SHED

The carriage sheds which date back to the 1850s which were designed by Sir John Benson, Joshua Hargrave and John Bagnell. These limestone buildings are now the centre focus of the Horgans Quay development and will be restored and integrated into the scheme. The two Carriage Sheds will form a new retail/ restaurant space with ground and first floor accommodation and extensive outdoor seating.
