## THE PROPERTY

Impressive well-designed detached four bedroom two storey residence on excellent site in the world-renowned Mount Juliet Estate and enjoying fine views over the Estate, the golf course and adjoining countryside. It is very bright throughout with large picture windows. It has 4 double bedrooms with 3 ensembles.

The Glen is located in a private cul-de-sac off Foxes Covert and is comprised of just four large detached houses on their own grounds.

No. 4 The Glen was designed by award winning CCH Architects and is a large detached two storey residence with excellent living and bedroom accommodation. It has a floor area of 3,605 sq.ft / 335 sq.m. It contains numerous interesting design features.

The ground floor comprises a spacious double height entrance hall, a very large dining area leading onto a superb double height livingroom, an extensive fully fitted kitchen, breakfast area and separate lounge area in the bay window, a large utility room, a double bedroom with dressing room


and ensuite. There is a cloakroom with w.c. and w.h.b and a hot press.

The first floor contains the very large primary bedroom with ensuite and spacious walk-in dressingroom, It has a balcony which enjoys fine views over the 4th fairway of the golf course. There is another double bedroom with walk-in dressing area with wardrobes and ensuite off it. The fourth bedroom is currently used as a study.

There is parking for several cars. There is gas fired central heating. There is a large barbeque area.




**Ground Floor Plan**
