Location

- Western Industrial Estate is located just off the highly accessible Naas Road (N7) and Nangor Road (R134)

- The proximity to the M50 makes for easy and rapid access to all arterial routes
- Dublin Airport and the Port Tunnel are situated approximately 24 km to the north east
- The area is host to high profile occupiers such as An Post, DHL and Electrolux
- The estate is serviced by Dublin Bus and the Red Line Luas is situated approximately 20 minutes walk from the Red Cow

- Twin skin asbestos roof with perspex roof lights
- Clear internal warehouse height of 5 metres rising to 6 metres at eaves

- Two storey office accommodation finished to a modern specification and predominately open plan
- Office accommodation includes suspended ceilings, painted walls and carpeted concrete floors
