This property is part of the redevelopment and restoration of the old Coach house in Johnstown village. The coach house was an important link in the Bianconi stagecoach route in the 18th century. It is across the road from the medieval church established by the Knights Hospitallers of St John who gave the village its name.

This is a bright and airy home with high ceilings and large sash windows with beautiful joinery. It includes a lovely terrace which offers access to the communal courtyard.

Set in the heart of the village, with restaurants, shops and creche just a short walk away, it is also just a few minutes' drive to Naas town with its many shops, boutiques, restaurants, bars, hospital, theatre, cinema, schools and sporting facilities.

For commuters, access to the M7 is two minutes away at Junction 9, the Arrow train service is a short drive away in Sallins and the Luas line at Citywest is a 15 minute drive. The 126 bus to Dublin and Kildare also stops in the village.

The well-proportioned accommodation in this fine property briefly comprises living/dining room, kitchen, guest wc, hall, landing, 2 bedrooms and bathroom.

Living Room/Dining Room 6m x 3.21m (19'8" x 10'6"): The living/dining room is a bright space, full of light, with a large window to front and French doors to rear leading to the terrace. It features an oak wide plank laminate floor and a cast iron fireplace with marble surround, granite hearth and gas fire.

Kitchen 2.4m x 2.08m (7'10" x 6'10"): This kitchen is fitted with beautiful cherrywood shaker style cabinets topped with granite counters. It includes oven and hob, washer/dryer, integrated dishwasher and fridgefreezer, gas boiler and a kickboard heater. It has attractive tiling to floor.

Guest WC 1.29m x 0.93m (4'3" x 3'1"): With wc, whb and travertine marble tiled floor.

Hallway 1.02m x 0.83 (3'4" x 0.83): With tiled floor.

Landing 3.36m x 2.78m (11' x 9'1"): With carpet floor

Bedroom 1 .31m x 2.68m (.101'8" x 8'10"): This is a spacious double room to rear with a selection of fitted wardrobes and carpet floor

Bedroom 2 3.2m x 2.27m (10'6" x 7'5"): This is a double room to front with fitted wardrobe and a carpet floor.

Bathroom 2.51m x 2.07m (8'3" x 6'9"): The stylish bathroom boasts quality fittings and tiles. It is beautifully tiled in travertine marble with mosaic accents. It includes a bath with overhead shower, WC and wash basin. With hotpress off and attic access.

Outside To front is a private parking space. To rear is an enclosed cobble locked terrace, with gate to the landscaped courtyard and car park. It has a wooden shed (1.9m x 1.25m).
