






The draft Cork County Development Plan 2021 has been published and will supersede the extended Town Council Development Plan once enacted.

The Circa 5 acre site has a specified zoning objective, reference YL-I-02, for port related activities.

The Circa I acre site falls within the town centre zoning objective, reference YL-T-01, to represent the primary and preferred location for any new retail development in Youghal. The Circa I acre site also has a specific zoning objective as a regeneration area, reference number YL-R-06 to state that this site is of great importance to the overall development of the town and is considered essential that an overall framework masterplan is prepared for the site in its entirety which will address its unique characteristics on the waterfront and provide for a coordinated approach to its development.








