Built in 2000, Cormorant Lodge is an outstanding four-bedroom home occupying an elevated site at The Lynn's in Annagassan. This architecturally striking home offers a rare opportunity to acquire a substantial modern property in one of the most picturesque and soughtafter coastal settings in the North East.

Set overlooking Annagassan Harbour, the property has been designed to maximise its stunning surroundings and setting. The accommodation at Cormorant Lodge is generously proportioned and thoughtfully laid out over two levels, offering a superb blend of open-plan living and private spaces. Accessed via the first floor, the entrance hallway immediately sets the tone for the exceptional quality and scale found throughout the home. A beautifully appointed kitchen, featuring bespoke cabinetry and premium finishes, opens into a spacious dining area, ideal for both everyday living and formal entertaining. The living room and family room are positioned to take full advantage of the surrounding views, with direct access to outdoor terraces. A well-equipped utility room and guest WC complete the first-floor accommodation.

The ground floor is dedicated to restful living, with a central hallway leading to four generously proportioned bedrooms. The master bedroom is a luxurious retreat, featuring a sleek ensuite bathroom and two walk-in wardrobes, offering ample storage and privacy. Bedroom two, bedroom three, and bedroom four are all well-sized and thoughtfully positioned.


Expansive picture windows, bespoke finishes, and a seamless flow of natural light combine to create a home of elegance and comfort.

GROUND FLO Approximate Floor Area, 581




