



Ballybregin: Dunhill: Co. Waterford

c. 148 Acre/59.89 Hectare: Non Residential Holding





Substantial non-residential grass land holding of c.148 acres located c. 3.5km from Kill and c.6.5 km from the Village of Kilmeaden in Co. Waterford. This sizable holding is mainly in permanent pasture, with a portion under forestry. The land is divided by the main Waterford to Kill R681 road, with c. 0.5 Km of road frontage at either side of the road. The property consists of c.58.60 acres to the Northern side of the road of which 40.85 acres is in permanent pasture, and 17.75 acres is under Forestry. The remainder of the property extends to c. 89.40 acres all in permanent pasture, together with a compact farm yard to the southern side of the road. The land is all of very good quality, suitable for a variety of farming enterprises. The farm yard consists of a three span shed and lean-to with cattle handling facilities and old stone cattle shed. The yard is serviced with mains electricity, and a private well water supply also exists which services the farm water network.
