Bardon Court is situated on the Main Street in Kilcullen a small provisional town c.28 miles south west of Dublin just off the M9 Motorway. The town has the benefit of schools, church, restaurants, pubs, shops and bank all on your doorstep. Local amenities include rugby, soccer, GAA, swimming, fishing, canoeing, horse riding, leisure centres, hockey, tennis, racing in the Curragh, Naas and Punchestown all within a short drive. The river Liffey meanders through the town with the larger towns of Naas (7 miles) and Newbridge (5 miles) offering an wealth of shopping facilities including the Whitewater shopping centre in Newbridge and Kildare retail outlet village only a 10 minute drive.

Employers in the area include the Bloodstock Industry, Pfizer Pharmaceuticals, Kerry Foods, Green Isle Foods, Q.K. Meats, Bord na Mona, Lily O'Brien's chocolates, Oral B to name but a few.

A good road and rail infrastructure is closeby with the M9 Motorway access c. ½ mile, bus route from the town and rail service from Newbridge or Sallins stations direct to City centre.
