LOCATION

The Tory Top Bar is located on a corner site with access from both Tory Top Road and Pearse Road. Directly adjacent to this property is an Aldi Store as well as a neighbourhood centre to include an AIB Branch, Mace Shop and Ladbrokes Bookmakers. The surrounding area is primarily residential in nature.

Irish Independent Park home of Munster Rugby is located approximately 350m walk from The Tory Top Bar while Cork City Football Club is located just a 350 m walk also. The Tory Top Bar is located approximately 2.5km south of Cork City Centre.

THE PROPERTY

The property comprises a part two storey licensed premises with an adjoining retail unit on a site extending to 0.26 acres.
