
















MEZZANINE FLOOR

HQ CORK

One of Ireland's most significant and exciting urban redevelopments. Spanning 6 acres along the River Lee, the development includes three LEED Gold Standard office blocks which when fully completed will accommodate over 3,600 people. No 1 Horgans Quay is fully constructed and has various tenants in place, No 2 Horgan's Quay is currently under construction which will provide an additional 128,000 sq ft of Grade A office space. The planned construction of over 300 apartments are also included within the development. The fully occupied adjoining Penrose Dock office development has also seen an influx of approx. 2,400 people to the area since its completion. The Horgan's Quay site's rich history dates back to the 1800s when the Great Southern & Western Railway Station first opened there.

PRIME LOCATION

The prime location of the Carriage Shed provides unrivaled access with vast appeal to residents, global firms and promising start-ups. HQ Cork is located less than 500 meters from the city's central bus terminus and is directly served by local and mainline trains via Kent Station. The site lies just a 15 minute drive to Cork airport - the country's second largest airport with domestic and international connections daily.

THE CARRIAGE SHED

The Carriage Sheds date back to the 1850s and were designed by Sir John Benson, Joshua Hargrave and John Bagnell. These limestone buildings are now the centre focus of the Horgans Quay development and are fully integrated into this significant urban scheme. The two Carriage Sheds form a potential retail/restaurant space with ground and first floor accommodation and extensive outdoor seating.
