LOCATION


The subject site is located in Hodson Bay, County Roscommon adjacent to Athlone Golf Club, The Hodson Bay Hotel and Lough Ree.

DESCRIPTION


The subject site comprises a greenfield located just off the N61 in Hodson Bay, adjacent to Athlone Golf Club and The Hodson Bay Hotel.



The subject site which extends to approximately 15 acres is irregular in shape and consists of greenfield land throughout.

The lands are generally flat, with defined boundaries made up of trees, hedgerows and fencing.

There is a 4-bedroom bungalow situated at the entrance to the site fronting onto the L2020 road. We understand this extends to approximately 177 sq m (1,900 sq ft). As stated, it borders Athlone Golf Club to the east and marshlands to the northwest.



ZONING

The Hodson Bay/Barrymore area is a distinctly different settlement type, which does not have its origins in a traditional village setting. It has instead evolved in part due to its lakeside position and the associated development of tourism and leisure facilities in the immediate vicinity, and has also developed as a soughtafter residential location on the periphery of Athlone.

- 7.5 Ac Zoned White Lands
