Description

The Convent which was built in 1927 is a substantial three storey residence in an attractive mature setting,

The residence extends to 1,027 sq.metres Having being refurbished in recent years the property is in good interior and exterior decorative order. The Convent is approached by a short mature tree lined driveway from a recessed entrance.

The residence briefly comprises 4 reception rooms, 21 bedrooms, kitchens, bathrooms etc.

To the front of the convent is a forecourt for parking over looking the Catherine McAuley Public Park. There is also a second entrance to rear.
