Location

Ennis Town Centre is well located in the heart of busy and vibrant Ennis. There is a strong and wide variety of retail in Ennis with brands such as Milano, Boots and Pandora all in immediate proximity to the scheme. More iconically, Ennis is renowned for its abundance of boutique and independent traders which creates a varied shopping experience.

Ennis Town Centre comprises 10 retail units and a large Dunnes Stores Anchor Store of 80,000 sq ft.
