After 5km, take a right turn onto Laytown Rd/R150. Continue on the R150, For Approx. 5km. At the roundabout take the 3rd exit. After 750m the destination will be on the right.

Take the R150 for 5km. Continue on the Coast Road/L5632. The destination will be on the left.













Ground Floor
