- No 12, The Main Courtyard has been creatively designed and styled with bright accommodation d has been recently redecorated. The property looking onto a parterre garden to the front and















mature gardens to the rear. It has plenty of character with high ceilings throughout, creating an overall effect of a cosy and stylish home. Serviced include mains water supply and electric heating. There is also an active management company to manage open areas with a management fee of 960 euros per annum.

- The Property is within walking distance of Kells Town. Kells is a heritage town situated one hour drive north west from Dublin City, 10 minutes from Navan town, 45 minutes from Dublin Airport Via M3 Motorway and a 2 hour drive from Belfast. It is serviced well by travel links such as the 109, 109A, 109X to Dublin Areas.
- Headfort Golf course and club is located in Headfort Demesne and within walking distance of the property. The club has a restaurant and bar open 7 days a week. There is also an active Bridge Club, Coral society and dancing classes run from the Golf club.
- Headfort Montessori is located within walking distance of this property in Headfort House. The Montessori caters for young children from 3 to 5 years and runs the government funded ECCE program for young children. Headfort School is an internationally renowned Preparatory School catering for children from 5 to 13 years of age.
- Other facilities include fishing from the Blackwater which runs through the estate. There is also a really good Tennis club in Kells Town.
- The town of Kells which is famous for the Book of Kells, is a heritage town which has lots of vibrant cafes, restaurants and shop with excellent schools and sporting facilities. Kells is also a thriving town which hosts many festivals and music events.
