LOCATION:

The property is located in the townlands of Sherlockstown and Prospect to the north east of Sallins c. 3.5km, Naas 6km and Clane 7km. M7 Motorway access is via Junction 9 (Naas North) leading both north and south.

DESCRIPTION:

The property is accessed via a cul-de-sac road which terminates shortly after the property. The property extends to c. 9.32 hectares (23 acres) together with cottage and yard and is held under Folio KE8939. The single storey cottage comprises c. 1,000 sq.ft. (92.9 sq.m.) with kitchen, bathroom, livingroom, utility and 3 bedrooms (in need of complete renovation). Yard comprises 3 span hay barn, outhouses and various stone buildings.

The lands are laid out in one block, currently in two divisions with extensive frontage onto the cul-de-sac. It is all in tillage with natural boundaries and hedgerows. The lands are classified in the Soils of Co. Kildare as "Straffan Series" which is in considered good quality and suitable for a wide number of uses.
