From Hollywood:

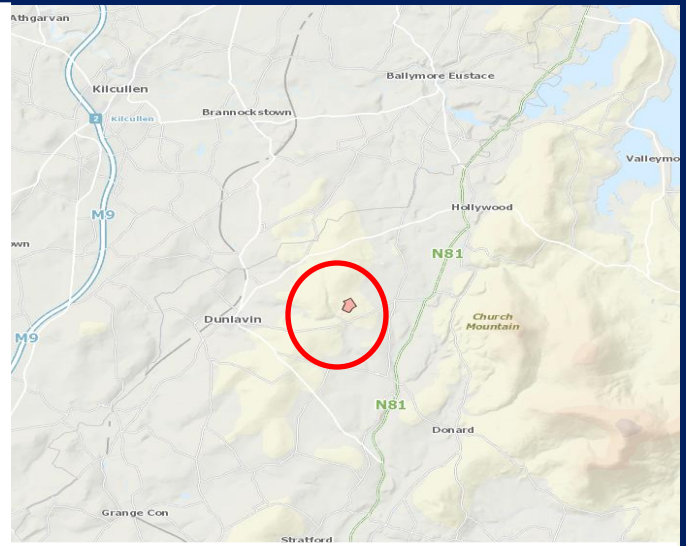
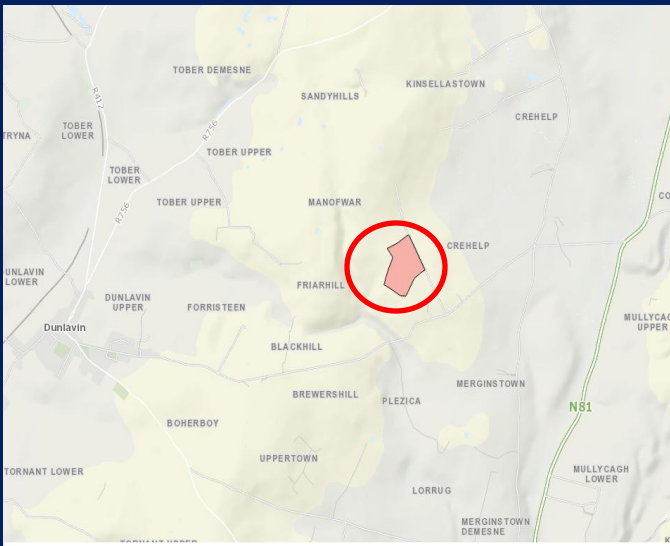
