DESCRIPTION

Prepared to be impressed by the tranquil lakeside location of this three bedroom bungalow with uninterrupted lake views. This property is situated on a quiet cul de sac on Luska Pier, filled with stunning views of the lake.

The lake shore property sits on a generous 1.03 acre site with only meters from the waters edge with breathtaking views of Lough Derg & has scope for further development if desired (subject to planning permission).

This charming residence offers well appointed accommodation comprising of an entrance hallway with parquet flooring. The open plan kitchen/living/dining area features tiled flooring, fitted units, cooker, tiled splashback and sliding doors to the front of the property offering superb lake views. The sitting room has the original timber flooring. There are three double bedrooms in this property, two of which have timber flooring and fabulous lake views. The main bedroom has carpeted flooring and an en-suite bathroom. The bathroom has tiled flooring, shower, W.C. and W.H.B.

Luska Pier provides access to Lough Derg, a majestic lake located between the counties of Clare, Tipperary and Galway where you will find activities to keep you entertained; sailing, canoeing, fishing, looped walked and magnificent scenery.
