LOCATION

We are delighted to bring this beautiful, quaint timber lodge to the market. Located on the Kildare / Wicklow border in a most desirable location overlooking the grounds of Russborough House. The property is located on a quiet country road equidistant between the village of Blessington and Ballymore Eustace being just under c. 4 kms and a two minute drive off the N81. The area has a host of amenities on your doorstep from nature walks, Hillwalking, water sports on the Blessington lakes and the Ballymore Eustace Ski-club, horse racing in the nearby Punchestown and golfing in Tulfarris, Blessington lakes golf club and Rathsallagh House. For day to day living there are a selection of good quality coffee shops and eateries, crèches, schools, churches and shopping in either Blessington or the nearby larger towns of Naas and Newbridge.

DESCRIPTION:

One of a kind timber lodge set amidst stunning gardens of c. 0.5 acres. The property is in excellent condition throughout being only 25 years old. It has wooden wainscotting, beautiful picture windows making the most of the garden views, wooden flooring and a large open plan living / dining room complete with wood burning stove. This is a very cosy home which would suit a growing family. It has four double bedrooms (master bedroom is ensuite) and upstairs there are three further attic rooms that could be used for a variety of uses. The heating is underfloor heating throughout. Outside is every gardeners delight with large lawned areas and mature shrubbery giving colour all year round. There is a cute chicken coop with fenced open space for the chickens to roam and a vegetable garden with fruit trees. The raised decking is an ideal sunspot and the detached garage with ESB is perfect for pottering and storage. This lovely family home is in a great location, early viewing advised.
