Sherry FitzGerald O'Reilly welcome you to 18 Pacelli Road, a three bedroomed end of terrace home set in a mature estate in the heart of Naas town and close to the banks of the Grand canal.

This property is perfectly located within a short walk of Naas town centre. It is walking distance to most Naas schools, both primary and secondary, creches, shops, leisure centre, library, playground, skatepark, canalside walks, restaurants and bars. It is a short drive to the M7 and the Arrow train station in Sallins. The bus service to Dublin is just a five minute walk away.

The accommodation briefly comprises entrance hall, hall, living room, kitchen/dining, guest wc, family room, back hall/side storage/storage room. Upstairs 3 bedrooms and bathroom. Outside – boiler house.



Accommodation

Entrance Hall 2.88m x 2.18m (9'5" x 7'2"): The entrance has an oak floor with carpet to stairs. Open to hallway.

Hallway 3.18m x 2.48m (10'5" x 8'2"): With oak floor and storage press off.

Living Room 6.2m x 3.15m (20'4" x 10'4"): The spacious living room feature a marble fireplace with open fire and an engineered oak floor. With double doors to the kitchen.

Guest Bathroom 3.3m x 2.2m (10'10" x 7'3"): The bathroom comprises a wc, wash basin and walk in shower. The shower features mosaic tiling to floor, and the bathroom walls are part tiled.

Family Room 3.62m x 3.48m (11'11" x 11'5"): This is a versatile room with a laminate oak floor.

Kitchen /Dining Room 5.78m x 3.45m (19' x 11'4"): The light filled Kitchen offers a selection of cabinets with a tile splashback. Included are a cooker with ceramic hob, dishwasher and fridge freezer. In the dining area, sliding doors open to the garden. Off the kitchen is a hall area (2m x 1.28m) with a linoleum floor.

Bank Hall Area 3.41m x 2.06m (11'2" x 6'9"): With uPvc door to garden and linoleum floor. Open to side storage and storage room.

Side Strprage 8.18m x 0.85 (26'10" x 0.85): With door to front driveway.

Storage Room 3.27m x 1.54m (10'9" x 5'1"):

Upstairs

Landing 2m x 0.88m (6'7" x 2'11"): With carpet floor. hotpress off and attic access.

Bedroom 1 4.18m x 2.7m (13'9" x 8'10"): This double bedroom has a carpet floor and rear view.

Bedroom 2 3.8m x 3.35m (12'6" x 11'): A double room to the front with a solid wood floor.

Bedroom 3 3m x 2.3m (9'10" x 7'7"): This is a single room to front with a wooden floor.

Bathroom 2.6m x 1.62m (8'6" x 5'4"): The bathroom includes a bath with pumped electric shower overhead, wc and wash basin. The walls are tiled and it has a linoleum floor.

Garden To front, the drive accommodates 3 cars off street. In the back garden there is a large paved patio, with a raised bed, grassed area and rose bushes.
