Location

- Greenogue Logistics Park is a one minute drive from the Naas Road (N7)
- This interchange is 8.5km south of the M7/M50 motorway Junction 9 which connects the M7 with the N4 and N81 Tallaght by-pass

- New detached high bay logistics facility of steel portal frame construction with a clear internal height of approximately 12.5 metres
- Concrete block walls to height of approximately 2.7 metres with insulated cladding above to roof level
- Attractive twin skin architectural elevations and twin skin insulated metal deck roof incorporating perspex roof lights
- Reinforced concrete floor to warehouse with power floated finish
- Quality three storey office building finished to include suspended ceilings incorporating recessed light fittings, plastered and painted walls, perimeter trunking with power and data points
- 6 dock levellers and 2 grade level doors
- Up to 40.7m yard depth
