The opportunity also includes a residential mews, developed in 1999, to the rear of the laneway (C.700 sq.ft/65 sq.m), which is currently occupied and subject to a Part 4 tenancy with a current passing rent of c. €1,600 per month (tenants not affected). Access to the mews is by way of a laneway (accessed from Church Road). To the rear of the property there is a large open yard, with potential parking for two cars.

Overall the property is in excellent condition and would suit a variety of uses, and will appeal to potential occupiers and investors. The opportunity has potential to expand and be further developed (subject to planning permission).
