









About this property

Savills proudly presents the beautiful Poulnacurra House which dates back to c.1741. This private period home is located on about 5 acres of grounds that also provides a one bedroom detached gate lodge, storage buildings and stables.

Upon arrival, an ornate, wrought iron electric gate opens inwards allowing access onto the beautiful descending driveway which is bounded by tall Cedar trees. Here, you will notice the one-bedroom detached gate lodge which has its own enclosed garden area. Making your way down the driveway brings you to a large parking area, a detached storage building with three interconnecting rooms and a private courtyard with stables. On the opposite elevation of the property, inspiring and meticulously maintained gardens await to be discovered. Here you will find a large greenhouse, secret gravel pathways, hydrangea walkway, lush and manicured lawns. There is also the most amazing array of plant and tree life to include Magnolia trees, Acer trees, Cornus tree, Arthur Bell, Bank of Boinka & Blanc Double de Coubert Roses, Cornices, Azaleas, Rhododendrons and a host more colourful and fragment planting.

Making your way up the limestone entrance steps, an attractive Virginia creeper adorns the entrance, stepping inside Poulnacurra House, you are greeted by tall ceilings, immaculate plasterwork and pitch pine wood floors. Accommodation on the ground floor key reception rooms include a living room, drawing room, dining room, study and kitchen/breakfast room. In addition, you will find a large utility room and storage room found off the kitchen/breakfast room. A guest lavatory grants access to a basement floor with original flagstone floor, three storage rooms which benefit from natural light.

Making your way up the gradually ascending staircase you will find seven doubles bedrooms, a nursery, bathroom and shower room. All accommodation at this level looks onto the beautiful and private grounds whilst each room maximises its natural light.

Poulnacurra House, lodge and lands offer themselves as a very rare combination in this location, the property itself is an ideal family home on a private site in a convenient location.

The site was once home to Poulnacurry Castle which was built by the Barry's around the 12th century and its remains are believed to have been used in part to help build Poulnacurra House.

Cork is Ireland's fastest growing city and the opportunity to acquire a prominent property such as Poulnacurra House, lodge and lands is a rare offering to the open market. 


