## **Accommodation**

• Entrance Hallway 4.69m x 1.85m

The entrance hallway has three recessed ceiling lights, one smoke alarm, one radiator, two power points, two phone points and laminate timber flooring. The guest W.C is located under the stairway.

Guest W.C 1.63m x 0.78m

The guest W.C has one W.C, one wash hand basin, ceiling light, tile floor and one window overlooking the side of the property.

Living Room 3.55m x 4.42m

The living room has one centre ceiling light, one window overlooking the front of the property and one radiator. Other features include six power points, open fireplace with timber and cast-iron surround and laminate timber flooring.



• Kitchen 6.02m x 2.63m

The kitchen has one ceiling light fitting and four recessed lights in the kitchen area. One window overlooks the rear and a door allows access out to the rear garden. The kitchen has built-in units at eye and floor level, an integrated fridge freezer, electric hob and oven. The kitchen also has plumbing for a washing machine and drier.

• Stairs	and landing	3.07m x 2.06m	The stairs and landing have carpet flooring throughout. The landing has one centre ceiling light, access to the attic and the hot press is also accessed off this area. The hot press is shelved and includes the hot water cylinder with electric immersion.
• Bedro	om 1	2.97m x 3.83m	The main bedroom includes one centre ceiling light, one window to the front of the property, one radiator, four power points and timber flooring. The bedroom also has an en suite bathroom.
• En Sui	te	0.91m x 2.43m	This en suite is fully tiled and includes a Mira Elite 2 electric shower in a shower cubicle. Features include one wash hand basin, one W.C, one centre ceiling light and one extractor fan.
• Bedro	om 2	3.4m x 3.21m	A double bedroom with one centre ceiling light, one window to the rear of the property, one radiator, four power points and a timber floor.
• Bedro	om 3	2.47m x 2.75m	This bedroom has one window to the front of the property, one ceiling light, one radiator, a built-in wardrobe over the stairs, two power points and timber flooring.
