Placed just 3.2 kilometres from Gorey and with ease of access to the M11, makes this an easy commuting neighbourhood.

On entry you are welcomed to the large reception hall, to the right lies a kitchen/dining/ living with double doors to the well-proportioned sitting room. Along the corridor are three well-proportioned bedrooms two of which have their own ensuites and a family bathroom. Upstairs, there is a bright and airy landing with a further three attic rooms that provide a versatile space.

Outside, the property is approached by a sweeping driveway which leads to the front of the house. The front garden and driveway border have been landscaped with a variety of mature shrubs and trees with an expansive lawn and is a south facing with a wonderful sense of privacy and seclusion.
