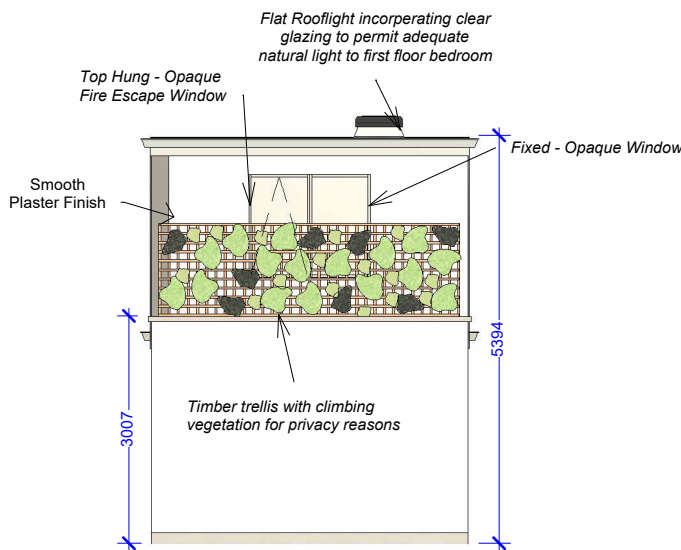

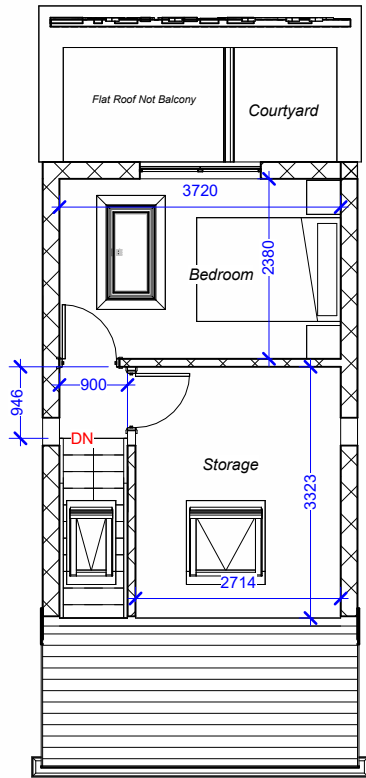
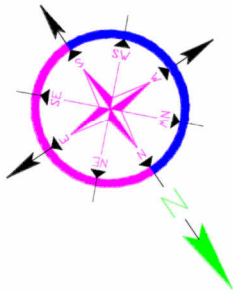
Front Elevations



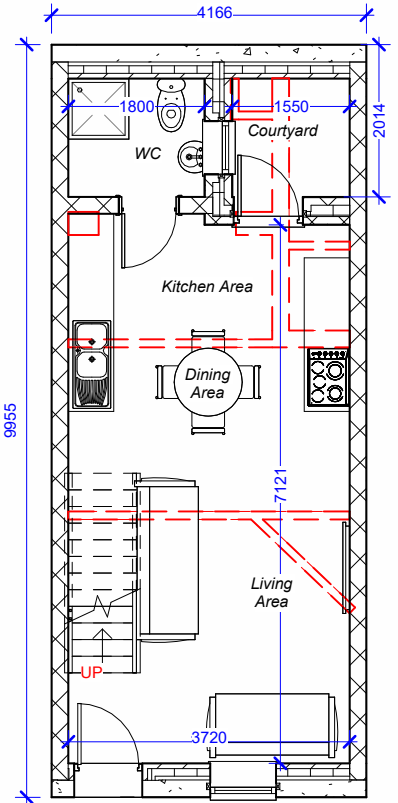

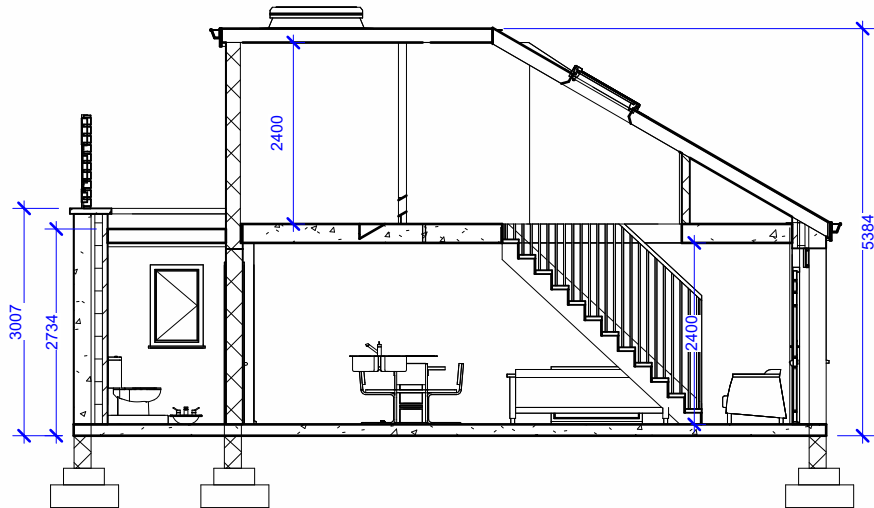
Rear Elevations



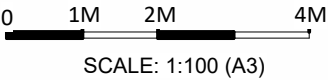
First Floor Plan
