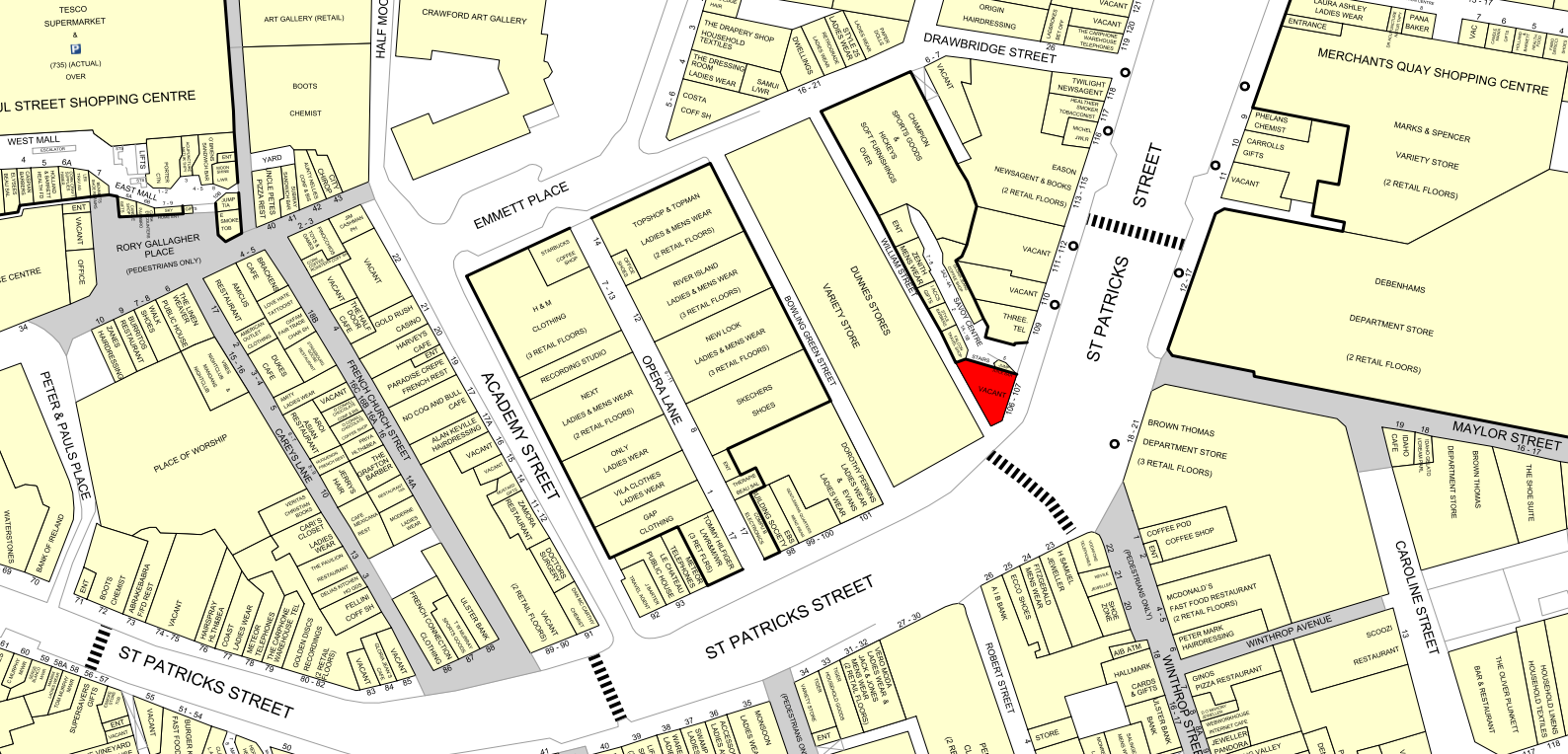

LOCATION

DESCRIPTION
