The property is conveniently situated within walking distance of Monread Shopping centre, Globe retail Park, Monread Park, local shops, school, creche, leisure centre, cinema and GAA. For the commuter, this home boasts effortless access to the M7/N7 motorway and the commuter rail line in Sallins.

Accommodation in this beautifully presented home briefly comprises hallway, living /dining room, kitchen, 2 double bedrooms (one en-suite) and bathroom. Balcony outside.

Hallway The hallway is floored with a warm walnut laminate which continues through to the living area. It has a hotpress off which has been recently fitted with a new tank and immersion.

Living Dining 5m x 4.34m (16'5" x 14'3"): This is a wonderfully spacious, light filled room of dual aspect. It features a fireplace with a cosy electric stove and is floored in a walnut laminate.

Dining Area 2.87m x 2.38m (9'5" x 7'10"): The dining area is generous in size and has a walnut laminate floor.

Kitchen 2.46m x 2.32m (8'1" x 7'7"): An archway from the living area brings you to the kitchen. The kitchen is fitted with a range of elegant shaker style cabinets with a tiled splashback and tiled floor. It includes a ceramic hob, oven, new fridge freezer and it is plumbed for a washing machine.

Balcony 4.64m x 1.79m (15'3" x 5'10"): Just off the living area is the balcony, laid with a synthetic grass which enjoys direct sunlight all afternoon and evening.

Bedroom 1 4.71m x 3.6m (15'5" x 11'10"): This is a very generous double room with fitted wardrobes and luxury carpet floor.

En-Suite 2.61m x 2.16m (8'7" x 7'1"): The roomy en-suite comprises wc, wash basin, a new corner shower enclosure and a separate bath, with attractive tiling to floor and walls. It features both centre and wall lighting, extractor fan and fan heater.

Bedroom 3 3.9m x 3.46m (12'10" x 11'4"): Bedroom 2 is an ample double room with built in wardrobes and a quality carpet floor. floor.

Bathroom 2.32m x 1.84m (7'7" x 6'): The bathroom is fully tiled and fitted with a suite of wc, wash basin and corner shower cabinet with electric shower. It includes an extractor and a fan heater.
