

LOCATION

Cork is the second largest city in Ireland with a population of just over 200,000 (census 2016). Cork is a major tourist destination and is also a University City with approximately 30,000 resident students.

Patrick Street is Cork city's premier retail thoroughfare and is home to several international and national retailers including M&S, JD Sports, Dunnes, H&M, Topshop, Gap, Tommy Hilfiger, Penneys, TK Maxx as well as Brown Thomas.

DESCRIPTION

The property comprises a high profile four storey premises with retail at ground floor. The upper floors currently provide storage. However, Cork City Council have issued a Section 5 declaring the conversion of the upper floors to residential use is exempted development. This permits the conversion of the 3 upper floors into a substantial 3 bed residence over 3 floors, all with commanding views of the River Lee. It also permits installing a separate access doorway from Patrick Street making this Triplex apartment self contained. This could generate considerable additional rental income. The property benefits from a modern shop front and a high profile to the busy intersection at Patrick Street and Lavitt's Quay.
