## **LOCATION:**

The subject property is located in The Nangor Road Business Park, a modest, well maintained, privately managed business park. It is located 7 kilometers south-west of Dublin City Centre, along the M50/Naas Road (N7).

Excellent public transportation is accessible, with a QBC on the Nangor Road and feeder buses linking to the LUAS Red Line from Park West.

## **DESCRIPTION:**

The subject property comprises a corner warehouse and office unit in Nangor Road Business Park.

The unit comprises concrete portal frame construction with profile metal wall cladding and metal decked roof incorporating translucent roof lighting supported on steel purlins.

The warehouse is accessed via an automated sectional up and over grade door.

This area also includes a concrete mezzanine floor.

Eaves Height is c. 3.30 m

There is offices on the ground and first floor of the unit. The offices comprise a mix of open plan and cellular offices.

The property presents in turnkey condition for any occupiers seeking new accommodation.

Unit B3 is powered by 21 x 530 Watt Solar PV Panels and has a new Air Conditioning System installed (full details available).

The unit has the benefit of 12 parking spaces.
