







About this property

Fort Royal

Extending to approximately 10,118 sq ft, and presented in good condition, the property is laid out in such a way that it will suit a variety of uses including hospitality, nursing home, residential etc. subject to the attaining the relevant planning permissions.

The accommodation is laid out over three floors and a key characteristic of the property is the extent and flexibility of the internal accommodation, with the ability to host both large and smaller events. The property is in good order and with very little capital expenditure, could become income producing quite quickly.

The ground floor accommodation briefly consists of conference room/events space, restaurant facilities, a lounge, offices, toilets, kitchen, and numerous smaller reception and storage rooms. On the first floor, there are 9 bedrooms suites (8 of which are ensuite) and associated storage and linen rooms. Up the stairs to the second floor are 5 bedrooms, 4 of which are ensuite, including a family suite.

Soldiers Cottage / Stable Cottage / Garden Cottage

A characterful two-storey building is situated to the side of the main hotel. It presently comprises 3 independent residential units with multifunction accommodation. They are in different stages of repair but have

the potential to be a superb addition to the main property in the form of guest or staff accommodation.

In all these properties extend to approximately 301 sq. m / 3,240 sq ft. The full extent of the cottage's accommodation is as shown on the accompanying plans.

Site

A planning permission (Donegal Ref :2050056) was granted for a standalone detached property on about 2.4 acres which would have the benefit of a panoramic sea view and direct access to the beach. This planning has expired but there is an application currently working through the planning process to renew same. The asking price of the site is €500,000 and is separate to the €1,600,000 asking price for the Fort Royal.

There is also planning permission in place to knock down the dining room extension to restore the original front façade and to convert the toilet/store to a living room.

Gardens

The gardens are one of the main attractive features of the whole property. The mature setting offers privacy to the world outside and presents the owner with the choice of a woodland or a beach walk. The mature trees, enclosed private gardens, well-kept lawns and access to the beach make this site a truly rare find.

















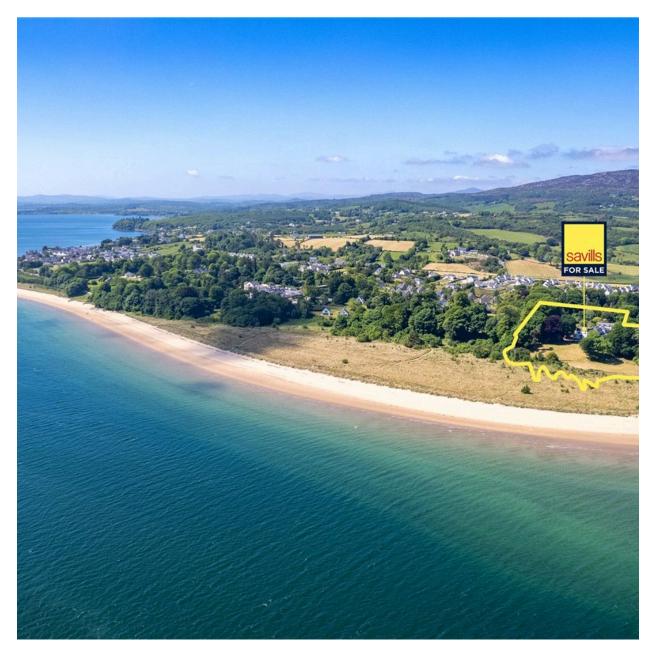
